What should my child bring to school?

Child's teacher will provide specifics.

- Backpack
- Extra face covering/mask
- Personal Supplies (choice time bag)
- Small, independently manageable snack for recess
- Water Bottle water filling stations available, but not water fountains
- Extra set of clothes TK
- Extra sweatshirt/sweater –
 windows/doors will often be open –
 learning will sometimes be outside



In the Classroom...



- Students will go directly to the classroom upon arrival
- Student will have their own desk with their own supplies and materials
- Plexi-Glass on teachers' desks
- Sneeze Guards on all student desks
- Windows/Doors remain open
- Procedures will be taught and reinforced regarding:
 - Keeping 6 ft. distance between each other
 - Proper mask wearing
 - Handwashing
 - Restrooms
 - Telling the teacher if a student is not feeling well
 - Dismissal time and getting ready to go home



Recess/ Snack

- Each class will have their own recess time
- Within each class, students will be divided with ½ eating snack and ½ playing (then students will switch)
- Playtime students can:
 - Use play structure
 - -Use chalk
 - Music/Dancing
 - Play organized games with yard supervisor like Simon Says
- Students will wash hands both before and after recess
- Pack a snack that your child can "manage" independently – small snack



Playground Procedures



- Managing physical distance for students along with appropriate mask wear are components of outdoor time.
- Students and staff should remain 6 feet apart and wear masks.
- There will be a designated "safe space" for students to have a mask break during outside time, during high energy activities, and warm days.
- Students can play on playground structures. Students will wash or use hand sanitizer before and after using the structure. The Custodian/staff will disinfect "high touch areas" often throughout the day.
- Any shared bins or play equipment will remain off-limits.
- While outside and during adult directed games/songs, students will stay 6 feet apart. Recess time will be staggered to maintain physical distancing.

Cleaning Schedule/ Classroom Set-Up

- Cleaning and sanitizing will happen a minimum of 3 times per day
 - All surfaces are wiped down and then sprayed with a non-toxic/non pesticide solution
- Playground/Tables will be cleaned between cohort use
- Classroom tables will be cleaned between cohorts
- All rooms have a sanitizing spray available at all times
- Plexiglass/Desk Dividers will be used
- Classroom arranged to allow 6 ft distance between desks – otherwise plastic desk/dividers plexiglass
- Students given their own supplies



Handwashing/ Bathrooms



Health Office


- Hand washing will be done regularly
- Hand washing stations will be added
- Bathroom/Sink use will follow distancing protocols
- No more than 2 students in bathroom at the same time
- Visual indicators of occupancy will be used on restroom doors

- Health Office available for everyday cuts/bruises and "owies"
- Secondary "isolation" room for any person experiencing Covid-Like Symptoms



Decision Pathways for Children Screened for Symptoms and Exposures Prior to Entry¹ into an Educational Institution

¹If child becomes unwell at the facility, place child in an isolation area (physically distant from attendant, ideally outdoors) and follow decision pathways described below.



Child is cleared to enter the facility.

2. Screening identifies child with 1 or more symptoms consistent with possible COVID-19 infection.*

Child is sent home. Parent/guardian instructed to consult Medical Provider for further evaluation and possible COVID-19 testing.

Institution determines if the child should be excused per illness management policy. Note, if the child's symptoms make it difficult for the child to comply with the facility's COVID-19 prevention and control measures, the child





Symptoms consistent with possible COVID-19 infection in children include: fever ≥ 100.4°F; new cough (different from baseline); diarrhea/vomiting. If the child's symptoms are not consistent with possible COVID-19 infection but there is still concern, evaluation of the child by a medical provider is recommended.





- Know the symptoms of COVID-19 and **if your child is sick**, **please stay home**.
- Understand what a close contact is.
 - A close contact is defined as anyone who has been within 6 feet of an infected person for at least 15 minutes within 48 hours of when the infected person began feeling ill/symptoms.
 - Know that close contacts must be quarantined for 14 days after exposure and monitor themselves for symptoms of COVID-19.
- If your child exhibits symptoms consistent with COVID-19 while at school, your child will be taken to our designated isolation room, be given a medical mask to wear and remain with designated staff until you pick up your child.
 - You should seek guidance from your health care provider and get a PCR test for COVID-19.
 - Your child may return to school after a fever that is not COVID-19 related, when fever free for 72 hours without the use of any fever-reducing medications prior to returning to school.
