The following changes were approved by the Soleado Elementary PTA executive board and signed by the California State PTA on November 1, 2020. *Motion to adopt the following changes to the bylaws and standing rules of the Soleado Elementary PTA for 2020-2021- Hazel Kim moved to adopt the bylaws for 2020-2021, seconded by Theresa Bowker and adopted.* 

- a) Bylaws Article V, Section 2: Should list "seven (7) vice presidents."
- b) Bylaws Article V, Section 12: The *first vice president* shall notify the executive board when a vacancy occurs in the office of president. (change noted in bold italic)
- c) Bylaws Article IX, Section 2: ".....alternate and one delegate for every fifty (50) members or fraction thereof *with a maximum of seven* (7) *delegates.*" (addition noted in bold italic)
- d) "Members of the association and executive board may participate in and act at any meeting of the association and executive board via teleconferencing using equipment with which all association and board members participating in the meeting can communicate with each other at the same time. Participation in such meetings shall constitute attendance and presence in person at the meeting. Quorum shall be established by roll call and identification of individual members and executive board members."
