

What should my child bring to school?

Child's teacher will provide specifics.



- Backpack
- Extra face covering/mask
- Small snack for break time
- Water Bottle water filling stations available, but not water fountains
- Extra sweatshirt/sweater –
 windows/doors will often be open –
 learning will sometimes be outside



In the Classroom...



- Students will go directly to the classroom upon arrival
- Student will have their own desk with their own supplies and materials
- Plexi-Glass on teachers' desks
- Sneeze Guards on all student desks
- Windows/Doors remain open
- Procedures will be taught and reinforced regarding:
 - Keeping 6 ft. distance between each other
 - Proper mask wearing
 - Handwashing
 - Restrooms
 - Telling the teacher if a student is not feeling well
 - Dismissal time and getting ready to go home

Outdoor Learning

- Teachers can utilize tables outside their classrooms
- Teachers can also use various areas around the campus for outdoor learning opportunities







BREAK

- Students will be given a 15 minute break with their classroom cohort
- Students will wash/sanitize hands both before and after break
- Pack a small snack and water bottle
- Students will be 6 feet apart while eating their snacks.
- Students and staff will remain 6 feet apart and wear masks.
- There will be a designated "safe space" for students to have a mask break during outside time.
- Any shared bins or play equipment will remain off-limits.



Cleaning Schedule/ Classroom Set-Up

- Cleaning and sanitizing will happen a minimum of 3 times per day
 - All surfaces are wiped down and then sprayed with a non-toxic/non pesticide solution
- Classroom tables will be cleaned between cohorts
- All rooms have a sanitizing spray available at all times
- Plexiglass/Desk Dividers will be used
- Classroom arranged to allow 6 ft distance between desks – otherwise plastic desk/dividers plexiglass
- Students given their own supplies



Handwashing/ Bathrooms



Health Office

- Hand washing will be done regularly
- Bathroom/Sink use will follow distancing protocols
- No more than 1 student in bathroom at the same time
- Visual indicators of occupancy will be used on restroom doors

- Health Office available for everyday cuts/bruises and "owies"
- Secondary "isolation" room for any person experiencing Covid-Like Symptoms





 Screening indicates no symptoms and exposures for child.

Child is cleared to enter the facility.

Screening identifies child with 1 or more symptoms _ consistent with possible COVID-19.

Child is sent home.
Parent/guardian instructed to consult Medical Provider for further evaluation and possible COVID-19 testing.


3. Screening identifies child with symptoms not consistent with possible COVID-19.

Institution determines if the child should be excused per illness management policy. If the child's symptoms make it difficult to comply with the facility's COVID-19 safety protocols, the child should be sent home.

4. Screening identifies child as exposed to a person with confirmed COVID-19.

Child is sent home.
Parent/guardian instructed to
have child tested for COVID-19.
Child quarantines for 10 days
from last exposure to infected
person.

¹If child becomes unwell at the facility, place child in an isolation area (physically distant from attendant, ideally outdoors) and follow decision pathways described below.



Symptoms consistent with possible COVID-19 infection in children include: fever $\geq 100.4^{\circ}$ F; new cough (different from baseline); diarrhea or vomiting. If the child's symptoms are not consistent with possible COVID-19 but there is still concern, evaluation of the child by a medical provider is recommended.

Procedures followed when Positive COVID Test

In addition to following the Pathways outlined on the previous slide:

- 1. Notification to families within the same cohort of a positive individual
- 2. Notification to staff providing services to the cohort of a positive individual
- 3. Update the District's COVID-19 dashboard: www.pvpusd.net/dashboard/
- 4. Notify Los Angeles County Department of Public Health (LA DPH) in accordance with their guidelines







- Know the symptoms of COVID-19 and **if your child is sick, please stay home**.
- Understand what a close contact is.
 - A close contact is defined as anyone who has been within 6 feet of an infected person for a total
 of 15 minutes or more over a 24-hour period of when the infected person began feeling
 ill/symptoms.
 - Know that close contacts must be quarantined for 10 days after last contact with infected person. Monitor health from day 11 through day 14 after last contact.
- If your child exhibits symptoms consistent with COVID-19 while at school, your child will be taken to our designated isolation room, be given a medical mask to wear and remain with designated staff until you pick up your child.
 - You should seek guidance from your health care provider and get a PCR test for COVID-19.
 - Your child may return to school after a fever that is not COVID-19 related, when fever-free for 24 hours without the use of any fever-reducing medications.
- Call 211 for guidance to services or resources in Los Angeles County.



LACDPH Travel Advisory and Guidance Updated February 3, 2021

- Following is a summary of the <u>LACDPH Travel Advisory</u> and <u>Guidance</u>, which we are adhering to:
 - Avoid non-essential travel and stay within 120 miles of your residence.
 - All persons arriving in or returning to the County of Los Angeles from other states or countries, must self-quarantine for 10 days after arrival.
 - -If you are travelling internationally, you are required to show a negative COVID-19 test result or documentation of recovery from COVID-19 before boarding a flight to the United States. For more information, please consult the Centers for Disease Control and Prevention (CDC) Travel


